A MESSAGE FROM SUPERVISOR SMITH – TOWN RAILROAD SAFETY

Railroad safety and preparation for an emergency involving a toxic spill has been a priority of our Town administration since my early days as Supervisor. It was eight years ago that we initiated the request to CSX Transportation to give the Town prior notice when toxic or hazardous material would be shipped through Pittsford. Regulation of railroads falls exclusively under federal jurisdiction. Citing that, and what it described as risks to national security by publishing information terrorists could use to cause a toxic spill, CSX declined.

At the same time I was in communication with Senator Schumer's office about this subject. It was from those conversations I learned about the requirement imposed on railroads to inspect their bridges annually. I've always been concerned about the railroad bridge at the intersection of North Main Street and Washington Road. As a result, we were able to get regular inspection of the bridge by CSX. Recently we filed the annual request for another inspection.

The recent disaster in Ohio reminds us of the importance of this issue. At last week's Town Board meeting I outlined Pittsford's emergency response preparations and plans in the event of a rail accident.

Our preparations include a Railroad Emergency Plan in conjunction with the County Office of Emergency Management, a Significant Events Field Operations Guide, and checklists for emergency responders tailored to specific types of emergencies and hazards. Our plans are structured to first gain and maintain situational awareness. Then to support immediate life safety initiatives, to stabilize the situation, to support human needs such as food and child care, and finally to conserve property.

These plans are reviewed and updated quarterly by Pittsford's Emergency Team. This team consists of the Town's Fire Marshall, the Captain of Sheriff's Department Zone A, representatives of all fire departments that serve Pittsford, representatives of the Monroe County Office of Emergency Management, the County Department of Public Safety, the Town Supervisor and Chief of Staff.

In addition the Town keeps current at all times the binder containing all legal forms for the Supervisor to declare a state of emergency, to bring in state and federal

emergency services and all forms of resolutions that the Town Board would need to adopt in a special meeting called to respond to such an emergency.

I consulted again with the County Office of Emergency Management to obtain data about the Ohio train accident and to get a sense of how frequently toxic materials passes through Pittsford by train. That office receives an annual report from CSX – after the fact – that reports how often that happens. Unsurprisingly, it is deemed by federal law to be confidential.

In recent days Senator Schumer’s office has been quite helpful when I reached out to let me know of federal efforts for improved rail safety. Last night I advised the Town Board of pending federal legislation that would require shippers and rail carriers to provide advance notice to each state’s emergency response commissioner.

Frankly, that’s not good enough. In addition to prior notice to State officials, the new federal law should require such notice to County and Town officials as well.

I recommended that the Town Board write to our Senators and Congressman to support the legislation *and to change it* to require prior notice to County and Town officials as well as State officials, and to write to our representatives in the State Legislature asking them to support review of all aspects of State preparations for a toxic catastrophe. We will do so.

And although we have a sober view of the likely response, we’re writing again to CSX Transportation to ask them to give us prior notice of hazardous shipments.

Come what may, be assured that Pittsford is properly prepared to protect our residents in the event of such an emergency.

TOWN’S BUILDING PURCHASE TO SAVE TAXPAYER DOLLARS

The Town has accomplished its long-sought goal to house the Town Court in a Town building. This will save taxpayers \$113,000 per year in what we pay to rent the current Town court facility. The Town has rented this space since 2005.



We’ve now purchased the building at 57 Monroe Avenue for use as our Town Court. Forgoing annual rent payments means the Town will recoup the \$1.25 million purchase price for the building in 11 years.

State law requires every Town to maintain a municipal court. This purchase gives us the most cost-effective means to fulfill that duty.

The new building will provide us with much-needed additional community meeting space as well, for meetings and events of community groups and for Town events and programs. We’ve seen the demand for such space grow every year. Happily, we’ve found the right building to serve this purpose as well as to house our court.

The Town of Pittsford currently has a student



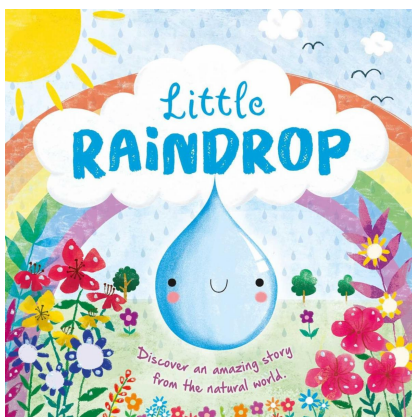
