




LIBRARY FALL BOOK SALE SEPTEMBER THIS FRIDAY & SATURDAY

PYS DUCK DROP IS THIS SATURDAY - TICKETS STILL ON SALE

Pittsford Youth Services' <u>Duck Drop Derby</u> is this Saturday, September 18 and tickets are still on sale! The annual rubber duck race on the canal will be held at 3:30pm in Carpenter Park at the Port of Pittsford, during the Town's Main Street <u>Food Truck & Music Fest</u>. Funds raised from this event go directly toward providing vital professional, confidential and affordable social work and counseling services to youth and their families in our



community. This year's Master of Ceremonies will be local comedian Todd Youngman.

The Duck Drop is Pittsford Youth Services' largest fundraiser. Contributions go directly toward services for youth and families in need right here in our community. PYS has been providing affordable, accessible and confidential counseling and support services since 1969 - for over 50 years! It's the perfect opportunity to be part of a fun community tradition while supporting the good work PYS does for our youth.

Admission to the Duck Drop is free and open to the public but if you want a duck to race, you have to buy a ticket! Buy your tickets online now and take advantage of the special "family of four" for \$30, or you can buy a "flock" of 8 for \$50. Individual tickets are \$10 each. The first three ducks to cross the finish line will win cash prizes of \$1,000, \$500 and \$250! There will be a silent auction too - held in front of the PYS offices at 4 South Main Street and featuring some special prizes!

Save our Canal Trees – Make Your Voice Heard The Canal Corporation/NY Power Authority are hosting four in-person public information sessions this Monday and Tuesday regarding their <u>Canal Corp/Power Authority</u> <u>Draft Environmental Impact Statement and proposed</u> <u>Embankment Maintenance Guidebook</u> and plans for

clearcutting trees along the canal. They will host two virtual meetings on September 30. Please see the details below.

The Canal Corporation/Power Authority deadline for comments has been extended to October 15. You can submit your comments to <u>NYSCC-Embankments@bergmannpc.com</u> in response to the <u>Power Authority's</u> <u>Environmental Impact Statement</u>, which outlines its rationale for clearcutting trees along the canal, and to its proposed Embankment Maintenance Guidebook.

You may also mail written comments to James Candiloro of the Power Authority at 30 South Pearl St. Albany, NY 12207. Comments must be submitted to the Power Authority by October 15, 2021.

SCHOOL TAXES DUE IN FULL BY OCTOBER 1

Full payments of school taxes for Town of Pittsford residents are due by Friday, October 1. Please include your stub and phone number with your payment. Consistent with our practice since the onset of the pandemic, the Town will continue to encourage payments by mail or by secure mail

slots which are located at both the front and back of the Pittsford Town Hall, 11 South Main Street. Full payments may also be made online via a link from the Town's website to the Monroe County website, using Visa and MasterCard only; there will be a 3% fee to use this online payment service. To pay online, click <u>HERE</u>.

On-time first installments may be paid at Canandaigua National Bank, 18 State Street, in Pittsford Village. Canandaigua National Bank will continue to accept full payments only from September 16 through October 1.

Second and third installment payments cannot be accepted at Town Hall. Second and third installments will only be accepted at the Monroe County Office of the Treasury (39 West Main Street, Monroe County Office Building) and made payable to: Monroe County Treasurer; they are not payable at Town Hall. Full payments with 2% interest will be accepted from October 2 - October 31 and these payments can be mailed or placed in the secure mail slot at Pittsford Town Hall. If you need assistance in that calculation, please contact the tax office directly at 585-248-6215 for the correct amount due.

Please Note: We strongly discourage paying your tax bill via Electronic Checking/Online bill pay system. If paying your bill with an online bill pay system, please be aware that your bank still mails us a paper check without a USPS postmark and it may take as long as two weeks to reach our office. Therefore, we cannot consider your payment received until we physically receive the payment in our office. We do not recommend sending payment in this manner.

COVID-19 Closure Updates

On June 15, 2021, Governor Cuomo announced that COVID-19 restrictions are lifted immediately as 70 percent of New Yorkers aged 18 or older have received the first dose of their COVID-19 vaccination series. The State's health guidance and New York Forward industry specific guidelines—including social gathering limits, capacity restrictions, social distancing, cleaning and disinfection, health screening, and contact information for tracing—are now optional for retail, food services, offices, gyms and fitness centers, amusement and family entertainment, hair salons, barber shops and personal care services, among other commercial settings.

On August 2, 2021, Monroe County was designated as a County with a "substantial" COVID infection. Consequently, the CDC now recommends that people, regardless of vaccination status, wear a mask indoors. This is a recommendation, not a mandate. The guidelines are unclear at this point, as is the situation. Neither the State, the County or the Town has imposed a mask *requirement* at this stage. pp

Unvaccinated individuals continue to be responsible for wearing masks, in accordance with federal CDC guidance. Consistent with the State's implementation of the recent CDC guidance, masks are still required for unvaccinated individuals.
