#### **Rick Taylor, Chairman:**

- Rick Taylor opened the meeting at 6:30 pm.
- August 2022 minutes were approved.

## Dept. of Public Works Update: Comm. of Public Works: Paul Schenkel Updates:

- Paul reviewed the various projects that were completed using the ARPA funding including:
  - a. Parking lot resurfacing, resealing and the addition of pickleball courts, at Thornell Farm Park.
  - b. Improvements to the driveway and parking lot at Isaac Gordon Park.
  - c. Upgrades to the dog park.
  - d. Heavy duty equipment purchases.
  - e. New ceiling fans at King's Bend Park lodges with window and siding improvements to be done.
  - f. Fencing, foul poles and fence toppers at Farm View Park.
- Future projects:
  - a. The addition of a pollinator garden and additional trees and shrubs at Great Embankment Park.
  - b. Trail connection and branding projects.
  - c. A pocket park at the empty lot on Main. St.
  - d. Improvements to various sites, including the DeBlase open space, Bromsgrove Hill, the Auburn Trail and the Daffodil Meadow.
  - e. A pavilion at the Spiegel Community Ctr.
  - f. Several new sidewalk projects.

## **Recreation Dept. Update:**

- Recreation Director: Jessie Hollenbeck Recreation Updates:
  - a. Jessie stated that Fall programs are underway. The After School program is currently full.
  - b. All the Senior programs are running well.

- c. The last week of August the maintenance dept. resets the building, which includes refinishing the dance/fitness/gym floors and building upkeep, i.e., painting repairing, walls, etc.
- d. The annual Music Food Truck Fest is this Saturday and Jessie requested volunteers to work at the town tent.
- e. Jessie stated that the Oct. Parks & Rec. Board meeting will be held at King's Bend Park.

## **Town Board Update:**

- Town Board Liaison: Kim Taylor Updates:
