



Ladies and Gentlemen:

The Town Board has previously received proposed Local Law No. 2 of 2025, which would amend Chapter 109 "Parks" of the Pittsford Town Code by adding a new §109.14 to govern the docking of boats at the town park of the Port of Pittsford.

Under the proposed new section, without the prior written consent of the Commissioner of Public Works, no boat may tie up to the dock at the Port of Pittsford town park for any time exceeding two periods of 72 consecutive hours during any 30-day period.

Existing section 109-13 of the "Parks" Chapter of the Town Code already makes any violation of the chapter punishable by a fine of up to \$350 for a first violation, so any violation of this new docking provision would carry that existing penalty.

A Public Hearing on the proposed Local Law has been scheduled for May 6, 2025.

A proposed, formal resolution to adopt Local Law No. 2 of 2025 is submitted herewith.

Recommendation is hereby made that the Town Board approve the proposed Local Law.

### **Adoption Resolution**

WHEREAS, true and correct copies of proposed Local Law No. 2 of 2025, amending Chapter 109 "Parks" of the Pittsford Town Code by adding § 109-14 to govern the docking of boats at the Town Park of the Port of Pittsford, were placed upon the desks of all members of the Town Board of the Town Board, New York, more than seven (7) calendar days, exclusive of Sunday, prior to the 6th day of May, 2025; and

WHEREAS, there was duly published in a newspaper previously designated as an official newspaper for publication of public notices, and posted upon the bulletin board maintained by the Town Clerk pursuant to § 40(6) of the Town Law, a notice of public hearing to the effect that the Town Board would hold a public hearing on the 6th day of May, 2025, at 6:00 P.M., Local Time, at the Town Hall, 11 South Main Street, Pittsford, New York, on said Local Law No. 2 of 2025; and

WHEREAS, the said public hearing was duly held on the 6th day of May, 2025, at 6:00 P.M., Local Time, at the Town Hall, Pittsford, New York, and all persons present were given an opportunity to be heard, whether speaking in favor of or against the adoption of said Local Law No. 2 of 2025; and

WHEREAS, the adoption of Local Law No. 2 of 2025 governing the docking of boats at the Port of Pittsford is essentially a traffic or parking regulation and is not an “action” which may affect the “environment” as those terms are defined under 6 NYCRR § 617.2(b) & (l), or alternatively, is a Type II action not subject to review under SEQRA pursuant to 6 NYCRR § 617.5(c)(21), (26), & (33); and

WHEREAS, subsequent to the closing of said public hearing, and after all persons interested had been heard, the Town Board considered the adoption of said Local Law No. 2 of 2025; and

WHEREAS, it was the decision of the Town Board that said Local Law No. 2 of 2025 should be adopted;

NOW, on a motion duly made and seconded, it was

RESOLVED, that Local Law No.2 of 2025: Amending Chapter 109 “Parks” of the Pittsford Town Code by adding § 109-14 to govern the docking of boats at the Town Park of the Port of Pittsford, be adopted by the Town Board of the Town of Pittsford, New York, to read as annexed hereto; and it was further

RESOLVED, that within twenty (20) days subsequent to the 6th day of May, 2025, there shall be filed with the Secretary of State one certified copy of said Local Law No. 2 of 2025.

Sec. 1            Title

This Local Law shall be known as “Local Law No. 2 of 2025: Amending Chapter 109 “Parks” of the Pittsford Town Code by adding § 109-14 to govern the docking of boats at the Town Park of the Port of Pittsford.”

Sec. 2            Amendment #1 to Existing Law

The Pittsford Town Code, Chapter 109 “Parks,” shall be amended by adding §109-14 to read as follows:

**§109-14. Permitted boat docking at the Port of Pittsford.**

The wharf area of the Port of Pittsford, between the Monroe Avenue and North Main Street bridges over the Erie Canal, is reserved for transient boat usage not to exceed 72 hours. Without the prior written permission of the Commissioner of Public Works, no boat may tie up to the dock at the Port of Pittsford town park for any time exceeding two periods of 72 consecutive hours during any 30-day period.


Sec. 3            Severability

If any clause, sentence, phrase, paragraph or any part of this Local Law shall for any reason be adjudicated finally by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby declared to be the legislative intent that the remainder of this Local Law would have been adopted had any such provision been excluded.

Sec. 4            Effective Date

This Local Law shall take effect immediately upon filing with the Secretary of State.

Ladies and Gentlemen:

As you know, the King's Bend playground is due for replacement. The existing playground was built in 2004 and is showing signs of wear. The manufacturer estimates a 20-year lifespan for their playgrounds, and there is significant wear and tear on this old playground. The rubber surfacing on the platforms is starting to peel off, and rust is encroaching. The paint on the posts is chalking, and the only elements geared toward the 2–5-year age range are a single tiny slide and two toddler swings. As a reminder, we currently have \$323,806 of ARPA funds available.

Town Board has strongly advocated the need for the replacement playground to have more ADA compliant elements and be significantly easier for individuals with disabilities to navigate and enjoy. We met with our Gametime representative, and she provided us with the attached plans. There are several free-standing elements strictly geared toward ADA accessibility, including the following:

- The Inclusive Whirl merry-go-round, which can accommodate a wheelchair.
- Spin With Me merry-go-round, installed at an accessible level for those in mobility devices to transfer from their device to a seat with additional postural support.
- Rox-All seesaw, with high backs and side rails. Each of the four seats on this innovative seesaw are designed to accommodate users of all abilities as they enjoy the rocking motion with their friends. The center saucer is designed for users to transfer easily to and from a mobility device.

Additionally, both the 2-5 and 5-12 year age range playgrounds will have accessible elements within them. Both playgrounds will have a transfer platform, so individuals in a wheelchair can transfer off and onto the playground platforms. There will be various ground level elements for all to enjoy which include djembe and bongo drums, a storefront panel, and gizmo panels. Several sensory elements will also be included such as a clicking hand cycler.

Our Gametime representative provided us with two playground options. Option 1 is the playground with a fully Poured In Place (PIP) rubber surface. Option 2 is the playground with PIP rubber pathways running to the main elements, with engineered wood fiber surfacing on the remaining portions of the playground. The attached renderings reflect the PIP paths for Option 2. The wood fiber is ADA compliant, but the rubber pathways would ensure that wheelchairs would be able to navigate more easily. There are benefits and drawbacks to both options. The full PIP surfacing requires less maintenance but is significantly more expensive. The pathway

option is more affordable but will require ensuring that the wood fiber chips stay off the rubber which involves raking to make sure there are not dangerous dips beneath swings, slides, and other high traffic areas.

Another option the Board discussed was a natural playground, comprised of natural elements such as tree trunks, climbing boulders, and the like. Upon investigation, we have learned that these playgrounds have almost no ADA accessible elements, and maintenance is difficult, given that the materials are prone to decomposition. We inquired about this type of playground with our insurance company, and were told they would not cover such a structure.

Additional upgrades that were discussed to make the park even more accessible include:

- Replacing existing stone dust and paver paths with concrete sidewalk and replacing the patios with new stamped concrete. The existing paths and patios are old. They have sunk and are cracked and in need of replacement.
- Add an ADA compliant fishing dock at the pond. Some points to consider are as follows:
  - i. Fishing generally only occurs in the forebay, the smaller pond, and the slopes leading to the pond are not accessible due to mud and plant growth.
  - ii. Plant growth, as well as a split rail fence is critical to keeping the geese in the pond rather than the grassing areas between the lodges.
  - iii. The dock would best be placed near the steeper edge of the forebay and should have a concrete walk leading up to it.
  - iv. The pond is a stormwater management facility, and the levels fluctuate frequently. By placing the dock at the steeper incline, it will not have to extend as far into the pond to ensure being over the water.
  - v. The dock structure should be similar to the dock at the Port of Pittsford with steel and concrete footers and a wood surface to ensure that it does not rot and is fully accessible.
- A second placement option would include a bridge over the channel between the ponds, and a dock installed on the earthen peninsula between them. This option could lead to the establishment of a future trail leading around the circumference of the ponds.
- With each of these proposed upgrades, it makes sense to repave and restripe the aging parking lot as well.



Securing a second contractor would provide greater flexibility in scheduling and efficiency. Bid specifications were carefully prepared, a legal notice was published in our official newspaper, and bids were publicly opened on April 30, 2025.


The bid results are as follows, with dollar amounts stated as cost per linear feet of 5' wide sidewalk and the cost of each detectable warning pad installed:




