#### OTHER BUSINESS

Supervisor Smith shared a further update on the highway employee union certification. The union has provided union signature cards and a certification of authorization to the PERB. They are verifying the signatures, and our legal counsel advises the certification of the union is imminent. Once this happens board members should meet with Town legal counsel regarding the next steps. Timing of that meeting will depend on when certification occurs.

Councilmember Townsend thanked staff for adding lighting district information to the Town website and asked, if possible, to add sewer and park district information as well.

Councilmember Koshykar asked where the Town was with website updating to a .gov. Supervisor Smith stated the Town has procured a .gov website.

Councilmember Havannavar questioned if there have been any inquiries from developers since the passage of the updated zoning code allow for mixed use spaces in the Monroe Ave corridor. The Supervisor noted that there have not been any such inquiries and that resevelopment of Monroe Avenue along the lines now permitted by our revised Zoning Code is something that we can expect to occur over time. It was suggested that partnering with the Pittsford Chamber of Commerce for an informational session could be useful.
