

# PITTSFORD TOWN BOARD ZONING UPDATE MEETINGS

The Pittsford Town Board will be conducting regular meetings to discuss the Town's Zoning Code Update.

**Meetings are tentatively scheduled for the second and fourth Wednesday of the month at noon through the end of 2021.** To comply with the State's most recent Open Meetings Law, as of August 25 meetings will be held in person at Pittsford Town Hall, 11 South Main Street, in the lower-level meeting room, unless otherwise noted. All meetings will be recorded and live-streamed via the Town website. Meetings are open to the public.
