

PITTSFORD TOWN BOARD ZONING CODE UPDATE MEETINGS

The Town of Pittsford is currently undertaking a Zoning Code Update. The Pittsford Town Board has been conducting regular meetings to discuss the Update. See details below for the 2022 meetings.

Meetings are tentatively scheduled for the second and fourth Wednesday of the month at 4:00pm through the end of 2022. Meetings will be held in person at Pittsford Town Hall, 11 South Main Street, in the lower-level public meeting room, unless otherwise noted. All meetings will be recorded and live-streamed via the Town website. Meetings are open to the public.
